Application details:	<p>Hose wash the surfaces with fresh water. Dilute 1:100 with fresh water (2 capfuls per bucket). Stir the cleaning agent thoroughly into the water. Wash the boat with a sponge and rinse well with fresh water. If there is direct sunshine, wash small sections at a time and rinse after each. Achieve high gloss by polishing with a soft cloth or buffing equipment when the boat is dry.</p>
